**2. MEPCO invites sealed bids on item rate basis under **Single Stage-Two Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.**

### ELIGIBILITY

**3. This Invitation for Bids is open to all Bidders complying the following requirements: -**  
Written request accompanied with copies of: -

- a) Pakistan Engineering Council valid certificate with at-least Category **C-3** having Specialization Code **CE-10, CE-02 & EE-05** must be provided.
- b) The bidder should have sound financial status. The difference between current assets and short term liabilities should be positive. Minimum average annual construction turnover calculated as total certified payments received for contracts in progress or completed, within the last five (05) years should be equal to **PKR 380 Million**.
- c) Participation in at least **one or two contracts** that have been successfully completed within the last **ten (10)** years and that are similar to the **proposed scope of work**, where the value of the Bidder's participation exceeds **PKR 80 Million** in one or two contracts (The bidder will submit completion certificate of the projects along with supporting documents).
- d) In case of JV, all the JV partners shall jointly meet the requisite criteria with the lead partner or other partner(s) meeting not less than **40%** and **25%** respectively of the said criteria.
- e) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- f) Identity Card of Contractor / Managing Partner / Director of the firm.
- g) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- h) **Income Tax Returns** for last two years.

**4. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 14.06.2023.****

5. A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs. 3000/ (Rupees Three Thousand Only)**.
6. All bids must be accompanied by a Bid Security amounting to **Rs. 7,600,000/-** (Rs. Seven Million Six Hundred Thousand) in favor of **Project Director GSC MEPCO Multan** of any scheduled bank having rating A+ and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
7. The bids will be opened at the office of **Chief Engineer (Dev.) PMU MEPCO Multan** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
8. Tender rates and amounts should be filled in figures as well as in words. Tenders documents should be signed as per general directions given in the tender documents.
9. All the procurement will be done according to PPRA Rules-2004.
10. Conditional / Electronic Bid shall not be permitted.
11. The bids covering partial and incomplete work shall be rejected.

- 1. Multan Electric Power Company (MEPCO)** invites proposals for pre-qualification of consultant for construction supervision of 132KV D/C Transmission Line from 132KV Shah Sadar Din G/S to feed for newly proposed 132KV FCCL G/S (26-KM approximately) (**Deposit work**).
- 2. Following are the major components of the said project.**
  - a) Vetting of Implementation schedule for Engineering / Construction activities
  - b) Construction supervision
  - c) Monitoring overall construction and delivery schedule and close coordination / liaison between concerned organizations / parties
  - d) Verification of contractor's bills and claims.
  - e) Measure final quantities and verification of final statement of payments due to the contractor(s)
  - f) To prepare and submit half monthly progress reports on physical and financial progress of the project.

The Consultant / joint ventures registered with Pakistan Engineering Council having minimum three (03) years of similar consultancy experience in 132-KV or higher voltage level projects with sound financial background and should have supervised construction of at-least three (03) Transmission Lines of 132-KV or higher voltage level as a consultant may apply with complete and comprehensive detail.
- 4.** The RFP will be available at the office of Project Director (GSC) MEPCO 2<sup>nd</sup> Floor MEPCO Operation Circle Building Khanewal Road Multan up to **14.06.2023** on payment of **Rs. 3000/-** (Rupees Three Thousand Only).

The technical proposal shall be opened by the committee on **15.06.2023** at **1200 Hrs.** in the presence of bidders / representative who wish to be present in the office of Chief Engineer (Dev.) PMU MEPCO Multan. The date of opening of financial proposals shall be communicated to the technically successful bidders accordingly.
