The rate quoted by less than 20% from analyzed calculated rates / previous approved tender rates, the contractor have to submit 05% of total bid as performance security in the shape of CDR within 15 days before approval of rates, in case of nonsubmission of 05% security within 15 days, the competent authority have rights reserved for cancellation of tender and 03% earnest money would also be forfeited, and no tender will be issued to default firm/contractor for further one year in PD Construction Directorate.
- The 05% security will be returned to contractor on successfully completion of works, otherwise security & earnest money will be forfeited.


