Bid Security/Guarantee for fixed amount not exceeding five percent of the estimated value of procurement mentioned in bidding documents in light of PPRA Rules (amended to-date) in shape of Deposit-at-Call, Bank Draft, Pay Order & Bid Guarantee issued by any scheduled Bank of Pakistan valid for **150 days** after the opening date of tender in favour of Chief Executive Officer MEPCO Multan must accompany with the Bid by the bidders, otherwise Bid will be rejected.
