2. Tenders will be issued to only those firms who are pre-qualified / enlisted with WAPDA/DISCO/NTDC/ (Approved contractors form the office of Chief Engineer (Dist.) Engineering WAPDA Lahore / Office of the Chief Executive MEPCO.
3. Cost of tender document is Rs.2000/- (Non refundable).
4. Tender completion period i.e. 60 days form the date of Agreement.
5. Earnest money @ 2% of total bid amount in the shape of CDR for each package/tender from the scheduled bank should be accompanied with the tender.
6. The Department/Company may reject all bids or proposal at any time prior to the acceptance of a bid or proposal as per PPRA Rules.
7. No. conditional tender will be accepted.
8. No. work order will be issued to the firm whose registration expired, unless it provides the fresh/valid registration certificate of PEC.
